With the intervention of the Chairman of this Tribunal; Ld. Counsels and the parties have agreed to settle the matter at as is where is basis. Separate statement of the appellant and the AR has been recorded.

The appellant has undertaken not to press the Contempt Petition bearing diary no. E-4779658/2025, withdraw the complaint before the SC/ST Commission, compliant before the Safai Karamchari Commission, appeal before the CIC. He also undertakes that he shall not press any complaint or any proceedings in any Court, Tribunal or authority qua the loan account no. 1966 against the Krishna Coop. Urban Thrift & Credit Society Ltd., its members, AR, staff or its Managing Committee.

As a corresponding goodwill gesture to the statement of appellant, Sh. Prakash Kishore Gupta, on instructions from AR Sh. Sudhir Kumar Singh, submits that N.O.C shall be issued to the appellant on the amount already received as on date. No further amounts shall be deducted or payable from the salary of the appellant to the respondent society.

In view of the settlement arrived at between the parties, it is directed that any amount which has not been disbursed by the DDO of the appellant to the O/o RCS or to the society, shall be payable to the appellant. Cheque Nos. 00585, 00586, 00587 & 000553 dated 25.07.2024 for the amount of Rs. 14,000/- each drawn by the DDO in favour of the Krishna Coop. Urban Thrift & Credit Society Ltd., shall be cancelled and the amount credited to the account of the appellant.

It is submitted on behalf of the society that N.O.C shall be issued within 15 days from today. During the period of interregnum, i.e. from today, 18.07.2025, till the N.O.C is issued, no further recoveries shall be effected by the O/o RCS from the salary of the appellant and the DDO, Executive Engineer, M-I, MCD, Division-Hathora Ram Park, Keshavpuram Zone, Delhi-110035, is hereby restrained from making any further recoveries from the salary of the appellant in loan account no. 1966 and in execution no. 07/2022-23.

The appellant shall have no claim towards the CD and share money deposited with the society or the interest accrued thereon. The amount already deducted from the salary of the appellant and transferred to the O/o RCS shall be payable to the Respondent Society.

Adjourned to 01.08.2025 for N.O.C to be brought to the Tribunal.
