Shinde further submits that he has instructions from the society to state that no coercive action or action towards expulsion of the appellant is intended to be taken by the current managing committee on the basis of minutes of meeting dated 22.01.2025.

In view of the good gesture of the society, appellant undertakes that he will cooperate with the society.

Sh. Harish, Senior Assistant from the office of RCS has brought records. However, as the matter stands settled, the TCR is returned.

The present appeal is accordingly disposed off as settled.
