Collector Grade-I, office of RCS to waive off the surcharge of 5 % in execution & recovery case no. 3243/24-25 titled as The Jeevan Co-operative Thrift & Credit Society Ltd. V/s. Smt. Alice Bhatia.

The prayer for wavier of 5% Surcharge is allowed. A division Bench of the Hon'ble High Court of Delhi in *W.P.(C) 2836/2018 titled as Kaushalaya Devi & Ors. Vs. Delhi Nagrik Sehkari Bank Ltd., decided on 02.12.2021*, has held that where the judgement debtor makes payment directly to the decree holder, no surcharge is to be paid to the office of RCS. Therefore, the amount, which has been paid out of Court, directly by the appellant to the respondent society is not liable to any surcharge.

AR of the respondent society submits that N.O.C shall be issued within two weeks from today. Ms. Masih submits that CD and Share Money of the appellant has been deposited with the society and the same be directed to be returned. AR of the society submits that since the appellant is a surety in another loan account and the amount shall be released to him as and when the said loan account gets settled.

Ms. Anjna on instructions from the appellant states that the matter stands settled between the parties and appellant does not want to pursue the present appeal and prays to withdraw the present appeal as not pressed with liberty to seek revival in case N.O.C is not received.
